#### Winton's Referral Program Terms & Conditions

#### 1. Introduction

Welcome to Winton's Referral Program ("**Program**"). This Program allows individuals ("**Referrers**") to earn a referral reward by referring new customers ("**Referred Customers**") to purchase a Winton prefabricated home. Participation in this Program is subject to these Terms and Conditions ("**Terms**"), and by participating in the Program you agree to be bound by them.

#### 2. Eligibility

<u>Referrers</u>: Any individual who is over the age of majority in his or her residence is eligible to participate as a Referrer in the Program, except for the excluded individuals set out in these Terms. For greater certainty, a corporation or other legal entity is not eligible as a Referrer. It is not required for Referrers to have previously purchased any Winton products.

<u>Referred Customers</u>: A Referrer can earn a referral reward under the Program if it refers a firsttime customer to Winton who (i) purchases a prefabricated home from Winton after May 1, 2024, and (ii) has not previously purchased any products from Winton. For clarity, purchases by Referred Customers of any products other than prefabricated homes do not qualify the Referrer for a referral reward, including but not limited to purchases of garages, shops, sheds and secondary dwelling units.

Excluded Individuals: The following individuals are not eligible to participate as a Referrer in the Program: (i) a director, officer or employee of Winton or any of its affiliates; and (ii) the members of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of any of the persons listed in (i) or of the Referred Customer.

<u>Proof:</u> Winton shall have the right at any time to require from the Referrer proof of identity and/or eligibility to participate in the Program. Failure to provide such proof may result in disqualification.

#### 3. How to Refer

To participate, the Referred Customer must provide to Winton the Referrer's name and e-mail at the time of their home order. This can be done through our sales process, either online or with a sales representative. Please contact Winton if you require any further instructions on how to participate. A referral cannot be added after an order is placed.

#### 4. Referral Reward

<u>Amount</u>: The Referrer will receive a \$1,000 reward for each successful referral. The Referrer is responsible for all taxes and fees that may be payable on such reward. Winton may at its discretion impose a maximum amount of total rewards that any Referrer may receive under the Program.

Condition for Issuance: The referral reward will be issued only after the Referred Customer has:

- a. purchased a Winton prefabricated home and paid for such purchase in full; and
- b. had their final shipment in respect of such home delivered.

<u>Payment Method</u>: Referral rewards will be paid to the Referrer via cheque within [**30**] days of completion of the final shipment of the applicable home. Details will be provided to the Referrer at the e-mail provided by the Referred Customer at the time of order, upon the successful completion of a referral. The Referrer must make arrangement to either pick up the cheque or provide an address to Winton for delivery of the cheque. Winton will not be liable in any way for misdirected or lost communications or mailings.

#### 5. Termination and Changes

Winton reserves the right to discontinue the Program and to terminate or change these Terms at any time and for any reason. Notice of any changes will be provided to participants via email or through our website.

Winton reserves the right to disqualify any referrals it believes in its sole discretion were generated in violation of applicable laws, are not legitimate or are from an ineligible Referrer and to take such other steps it may deem necessary to preserve the integrity of the Program including, without limitation, terminating an individual's right to participate in the Program, or delaying or cancelling the delivery of a referral reward. In all matters relating to the administration of the Program, Winton's decision will be final.

#### 6. Privacy

Participation in the Program may require participants to submit personal information about themselves and the Referred Customers.
